500—I200m altitude



Elevated above the Cardrona Valley, the land at Run 3 has a plateau suitable for a building platform at 725m altitude. The full site covers approximately <u>169 ha</u>, is <u>1.5 kms long</u>, and spans an altitude from <u>500m to 1200m</u>. This allows stunning views up and down the valley, and gives the guests almost total privacy from their surroundings.



The vision for Run 3 is a luxury lodge retreat where guests can escape, unwind and explore one of the most scenic parts of New Zealand.



Initial concept plans have been drafted to give an idea of how the land can be used – however the site will still allow the new owner to put their own stamp on their dream lodge.





The concept plans allow for a sprawling north-facing building to be created as the main luxury lodge, overlooking a high-country tarn or alpine lake to be created.



Supplementing the main building are a number of smaller chalets, modelled on the old mustering huts, for visitors wanting a place truly away from it all.







As a deep mountain retreat, the development at Run 3 will provide a very discreet and secluded visitor experience. Access to the property will be by way of a private road from the Cardrona Valley.

Zoned as Rural General, the vendor will assist in a combined resource consent application to allow for the new lodge.




#### Location

Run 3 is located a short distance off Cardrona Valley Road, to the south west of the new Mt Cardrona Station village and close to Cardrona Alpine Resort. Guests will be close enough to use these neighbouring facilities, but will be secluded by the private road that leads directly into Run 3 ¶

Along with its beauty and idyllic location, Run 3 is special because of its heritage J




The region was put on the map by the Otago Gold Rush of the 1860s. Mining communities rose up all over Otago, with the population of Cardrona village reaching some 1,000 people during the peak of the gold rush.



### Its origins

Run 3 was created in 1921 from a subdivision of Cardrona Commonage in the Knuckle Peak and Cardrona District as part of the Discharged Soldiers' Settlement Act.

Passed by the New Zealand Government after WWI, the Act was passed to help repatriate returned servicemen and provide opportunities for them
